## ✎ AUTHORS GUIDELINES ✎

Please address manuscripts of original papers, review articles, case reports and letters in the field of geriatrics in German or English to:

The papers must comply with the requirements on the publication of modern scientific information, and must not have been published or submitted for publication elsewhere.

Original papers or clinical investigations should be no longer than 8 to 10 manuscript pages, review articles about current scientific understanding in a particular field of geriatrics should not be longer than 10 to 12 manuscript pages, including illustrations and bibliography.

Letters as interim scientific communications (2 to 3 manuscript pages, 2 tables or figures) will be given priority.

All texts submitted in English will be checked by an English native speaker.

### Manuscripts

Manuscripts should conform to the Uniform Requirements of the International Committee of Medical Journal Editors (N Engl J Med 1997, 336: 309-315, <http://www.icmje.org/>) For texts in German the new German orthography is binding. Use „Duden: Medizinische Fachausdrücke“ for spelling.

The summary should provide the context or background for the study as well as the studies's purposes and basic procedures; main findings, and principal conclusions. It should emphasize new and important aspects of the study or observations. The title and key words in German and English must follow the summary.

All manuscripts must be submitted by e-mail ([ELang@t-online.de](mailto:ELang@t-online.de)). Exceptions will only be made in justifiable cases. The following word processors are accepted:

- Macintosh: Mac Write, Microsoft Word, RTF
- PC: MS-Word for Windows, Windows-Write, RTF

Enclose illustrations and tables separately with the manuscript. They must be of reproducible quality, numbered, and marked with the name of the author. Please keep the number to a necessary minimum (the upper limit is 6). Avoid repeating data in figures and tables. Summarise the legends with the numbers of the figures on a separate page.

The complete postal address of the author and co-authors (with name written in full and complete titles) must be given at the end of the manuscript. If the co-authors are subordinate to the author, the responsible head of the institution / institute / department must be given in parentheses.

The publisher will ultimately decide upon acceptance after evaluation by reviewers. Upon acceptance, the publisher shall acquire the exclusive rights of publication, translation into foreign languages and reproduction for the statutory copyright period.

In the case of books the bibliography must state; name and initials of the forenames of all authors or of the publisher(s), title, publisher, where published, and year of publication.

Where journals are quoted, the bibliography must state the name and initials of the forenames of all authors, name of the journal (abbreviated according to World Medical Periodicals), year of publication, journal name, volume, issue (in parentheses), and page numbers, including the first and last pages.

All references have to be innumeraed in alphabetical order (according to the name of the first author).
