## Where we were before Consortium



Vallisneri Library: paper only era

#### **1998:**

686 current print journals subscriptions absorbed about 80% of the Library acquisition costs.

Major problems to cope with:

- shrinking stack space
- increasing costs in maintaining paper collections
- redundancy of print copies in libraries of the same university

## Where we were before Consortium



## first approach to e-journals

#### <u> 1999:</u>

- Vallisnery Library started to manage electronic versions of print journals available by publishers with no surcharge. This included mainly the following commercial offers:
- free online
- free online with subscription to the paper version
- free online only for years previous to the current year

#### n. 89 e-journals available through our local catalogue



## Where we were before Consortium

access to the electronic resources

- homepage of the journal
- publisher catalogue
- vendor/aggregator catalogue and services



Where we were before Consortium problems to cope with

- Publishers commercial offers were abundant and variable
- Terms and conditions of licences use were heterogeneous
- Services offered to the library users were not homogeneous. Coexistence of multiple local catalogues

Where we were before Consortium problems to cope with



to mantain print subscriptions to access the electronic version

#### On the other hand

- cuts to economic supports to the library
- increase of US dollar value
- rise in subscription prices
  would have pushed us towards a massive print journal cancellation.

## Consortia

**Consortia alliances for acquisition of digital resources:** 

launching of the digital information market diminishing of traditional financial resources forced

the more reactive Italian University library systems to implement competitive strategies.

University of Padua - Italy



- CILEA (Milan) consists of 9 Universities of the Lombardia region + other institutions outside the consortium
- CASPUR (Rome) consists of 6 universities in central and southern Italy
- CIPE (Inter-Universitary Electronic-Periodicals Co-operation)
   University of Padua is member of CIPE



#### **<u>CIPE Project</u>**

• founded in 1999

• consists of 12 universities in the centralnorthern Italy

### **CIPE Project**

CIPE promoters, stakeholders and members belong to the library systems of the associated universities.

CIPE universities account for approximately 30% of the national spending in the sector.



### **CIPE Project**

- CIPE avails itself of a professional advice for negotiating:
- licenses directly with publishers and producers
- conditions of access to e-journals
- conditions for archive maintenance



#### **<u>CIPE Project</u>**

Acquisition policy, contractual strategies and negotiations are decided upon jointly by the institutional representatives of the member-university library systems, who partecipate in all negotiations.



#### **CIPE Project**

**CIPE** is based on a model of joint participation formalized in an agreement which also defines the administative and operational procedures.



### **<u>CIPE Project</u>**

**CIPE primary objectives are:** 

- rationalisation of expenses (shared collection policy)
- shared activities (analysis and study, negotiation etc.)
- sharing of resources and development of services



## Consortia

**Consortia problems:** 

- long-term preservation of electronic data
- delegating the workload among the various Consortium members
- cooperation with other Consortia (Interconsortial acquisition)



Vallisneri Library: advantages from Consortial cooperation

**1998:** 

**686** print journal subscriptions

<u>1999</u>:

89 e-journals available through Vallisneri Library local catalogue

#### <u>2002:</u>

43 print journals subscriptions cancelled.

**3401** e-journals available through the collective catalogue of the University of Padua (1513 of the biomedical area).



**Benefits for CIPE individual libraries:** 

- more favourable licensing terms
- legal advice and support to negotiations
- access to e-journals through a collective catalogue (Consortium acquisition, library subscription, free titles)
- services improvement



**Benefits for CIPE individual libraries:** 

- wider range of titles
- control over inflactionary costs
- optimization of management costs



### **Problems for individual libraries**

- lack of autonomy
- hardware and software investment
- new skills in managing electronic resources (IT, problem solving, educational)
- personal interactions
- marketing library services
